- The use of potentially hazardous or harmful products during construction processes and the safe disposal of them
- The disposal of waste, hazardous and potentially toxic materials to avoid environmental harm.

- The conservation of energy through management and selection of resources, equipment, plant and transport.
- The development, monitoring and investigation into future systems, practices and procedures in order to ensure that the environment remains a principal consideration.
- Utilisation of Telematics on plant to monitor efficiency and reduce idling time where possible to do so
- Use of more sustainable fuel sources as they are available to meet our requirements. For example: Hydrotreated Vegetable Oil (HVO) fuel in place of Diesel Gas Oil.
- Purchasing of plant with a bias towards engines compliant with lower the emission's compliance (e.g. Euro Stage V)
- Purchasing of Vehicles with a lower mass and greater fuel efficiency.
- Monitoring of company's Fuel usage and emissions to confirm actions taken are effective in reducing the environmental impact of the companies activities.
